## 2022-23 Tuition and Fees

### Kindergarten - Grade 8

- **Tuition** - \$7,000
- **Tuition Assistance**
  - Option 1 - Pursue State of Florida taxpayer supported scholarship programs
  - Option 2 - Complete application and tuition assistance needs analysis through TADS - *Needs-based awards are made based on calculated needs and available funds.*
- **Fees**
  - \$75 Application Fee
  - \$225 Registration Fee
- **Extended Care (7:00 - 8:10 & 3:30 - 5:30)**
  - Rates
    - Morning Session Only - \$4/day
    - Afternoon Session Only
      - 3:30 - 4:30 - \$5/day
      - 3:30 - 5:30 - \$9/day
    - Both Sessions - \$12/day
  - Late Pickup Charge \$15 + \$1.00/minute
- **Co-curricular Activities Fees** - To be determined

### Early Childhood Tuition (Full Time - 7:00 - 5:30 & Half Time - 7:00 - 12:30)

- **VPK Extended Day**
  - Morning Care Only - 7:00 - 8:30am \$25/week
  - Afternoon Care Only - 12:00 - 5:30 \$110/week
  - Full Day - 7:00 - 5:30 - \$115/week
  - Morning Care Drop-in Rate - \$10/day
  - Afternoon Care Drop-in Rate - \$30/day (As space is available)
- **Fees**
  - \$75 Application Fee
  - \$150 Registration Fee (1's, 2's, 3's)
  - \$100 Registration Fee (Full Day and Afternoon Care VPK Students)
  - \$25 Yearbook Fee (Optional for VPK only students)
  - Non-Instructional Child-Care Day - \$45
  - Late Pickup Charge \$15 + \$1.00/minute
- **Notes**
  - All students must meet age requirements on or before September 1
  - VPK Instructional Day - 8:45 - 11:45
    - VPK Only Students may be dropped off between 8:30 & 8:45
    - VPK Only Students are to be picked up by 12:00pm
- **Christ the King Academy Financial Policies**
  - Families are required to be enrolled in the TADS tuition management system and be on ***autopay***.
  - All balances from the previous school year must be paid in full by June 30.
  - Payments returned for insufficient funds will incur an additional **\$40** fee
  - Continued enrollment will be jeopardized for families with an outstanding balance of more than 60 days past due.
